# Wall Street Bancorp - Cookie Policy

This Cookie Policy explains which and for which purposes cookies are used by **Wall Street Bancorp (hereinafter referred to as "the Bank")** when using the website wallstreetibu.com

#### 1 Cookies – What and why?

Cookies are small pieces of information that are stored by your browser on your computer's hard drive or in your browser memory. When using wallstreetibu.com, it enables the Bank to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time. You do not have to keep re-entering these whenever you return to the site or browse from one page to another. For wallstreetibu.com, the Bank mainly uses the following cookies:

 - 'Strictly necessary' cookies: these are essential for you in order to be able to use wallstreetibu.com;

- **Functionality cookies:** these are used to provide you with the requested services and to remember your settings to improve your use of wallstreetibu.com;

– Third party analytics cookies: these are set by a third party that does not operate wallstreetibu.com in order to collect statistics on the use of wallstreetibu.com (e.g. to estimate the number of unique visitors, to detect the most preeminent search engine key words that lead to a certain webpage or to track down website navigation uses).
